## Party Bus Rules & Agreement

- It is illegal to hang out the windows or doorways while the vehicle is in motion. Please keep all body parts inside the vehicle while it is in motion. This will prevent injury and traffic stops from law enforcement.
- 2. Do not throw anything from the vehicle as it is unlawful to do so.
- 3. Smoking or Vaping is prohibited in our vehicles.
- 4. Be kind to others during the course of your trip. FIGHTS WILL NOT BE TOLERATED.
- 5. Bridgetown Transportation LLC is not responsible for delays or termination of runs in winter caused by unsafe road conditions (ie. Slippery roads, accidents, etc. Or for delays caused by traffic conditions.)
- 6. Bridgetown Transportation LLC is not responsible for articles left in the vehicle. Your driver has been instructed to check the vehicle for items left before the vehicle leaves your final destination.
- 7. Vehicles cannot be loaded beyond seating capacity.
- 8. Passengers must remain seated while the vehicle is in motion.
- 9. Alcohol is not provided by Bridgetown Transportation LLC.
- 10. Alcohol consumption is limited to passengers over the age of 21. Any passenger who consumes alcohol must be prepared to show photo ID to the driver.
- 11. Alcohol consumption is limited to the rear portion of the bus and may not be forward in the driver or loading areas.
- 12. Any alcoholic beverage must remain on the bus during the trip.
- 13. Drug use is prohibited by law.
- 14. When mixed age groups are on the bus (over/under 21), each passenger intending to consume alcohol will need to show the driver their government issued ID as proof of age. They will be issued a Tyvek bracelet to indicate that ID has been checked.
- 15. It is the policy of Bridgetown Transportation LLC through its drivers to contact authorities immediately if they witness or become aware of violation of drug use or underage drinking. The driver has the right to terminate the reservation if there is blatant indiscretion on the part of the passengers.

Upon entering any vehicle owned / operated by Bridgetown Transportation LLC, each passenger understands the following. Each passenger is aware that the vehicle will make frequent stops and starts while it is in operation. Each excursion may expose each passenger to the risk of property damage, bodily or personal injury. Each passenger may need to participate in certain physical activities such as lifting, crossing streets, parking lots and intersections. Each passenger understands that they may encounter risks that may cause transportation accidents, injury from falls, injury due to inclement weather, bumps, bruises, cuts and abrasions, muscle strains and sprains, and exposure to contagious disease which may cause death, as well as other risks that may not be foreseeable. Each passenger knowingly and freely assumes any and all such risks. In exchange for being allowed to participate in activities on any vehicle operated by Bridgetown Transportation LLC, each passenger chooses to hereby release and forever discharge and agree to indemnify Bridgetown Transportation LLC, its members individually and their officers, agents and employees from any and all claims, demands, rights, expenses, actions and causes of action, of whatever kind, arising from or by reason of any personal injury, bodily injury, property damage, or the consequences thereof, whether foreseeable or not, resulting from or in any way connected with participation in activities occurring on the vehicles. Each passenger further covenants and agrees, they will hold forever harmless and will not take legal action against Bridgetown Transportation LLC, its members individually, and their officers, agents, and employees for any claim for damages arising or growing out of participation in this activity whether caused by negligence or otherwise. Each passenger understands that the acceptance of this Release, Waiver of Liability, and Covenant not to sue shall not constitute a waiver, in whole or part, of any rights by Bridgetown Transportation LLC, its members, officers, agents, and employees. Each passenger must certify by signing below that they

understand and have read the above carefully before signature that they freely and voluntarily sign this Agreement, and contractually bind their heirs, executors, administrators, administrators, and assigns, as well and themselves and their parent or legal guardian must sign on their behalf.	that it is their express intent that this Agreement shall and assigns, and their child's heirs, executors,
